Overview

Colleen is recommended as a leading junior for both shipping and commodities disputes.

She specialises in commercial law with a particular focus on dry shipping, commodities and international arbitration. Colleen appears regularly before the Commercial Court and arbitration tribunals in disputes involving the international sale of goods, charterparty construction, cargo claims, energy claims and jurisdictional issues. She regularly advises and acts for shipowners' defence clubs and is happy to accept direct instructions. Colleen has acted for some of the world's largest commodity traders in sale of goods disputes and has particular expertise in oil and gas sale disputes. She has also advised in superyacht disputes.

Colleen has worked in-house at the Nordisk Shipowners' Defence Club in Oslo, where she gained a unique understanding of the day-to-day legal issues affecting shipowners. During 2007 she worked in-house in the anti-trust department of the Washington DC office of Morgan Lewis Bockius LLP assisting in part with the marine hose dispute. Commercial law and arbitration

In a recent appearance before the Commercial Court, Colleen successfully obtained judgment against a large West African oil company on behalf of a Swiss based trader. She has also successfully applied for several anti-suit injunctions and has recently acted in separate applications involving s. 67/68 of the Arbitration Act, freezing orders and the recognition and enforcement of foreign judgments. She frequently appears before a range of arbitration tribunals and has acted in a number of arbitration related applications in the High Court as well as security claims. Colleen has directly advised and acted for a number of P & I Clubs. During 2005 Colleen worked as an in-house adviser at the Nordisk Shipowners' Defence Club in Oslo where she gained a unique understanding of the day to day legal issues affecting shipowners. At present she is advising and acting for one of the world's largest shipowners in a substantial on-going arbitration dispute.

Colleen acted on behalf of Visa in the major competition decisions *Mastercard International Inc and Mastercard Europe SPRL v The Office of Fair Trading* and in *Inntrepreneur Pub Company and others v Crehan* [2006] UKHL 38 before the House of Lords.
